The above comparative report summarizies the Operating Income and Expenses of our Church and School for the fiscal years ended June 30, 2010 and 2011.

Church columns include: the Church, Rectory and Business Office; Religious Education; Music and Liturgy; Pastoral Ministry; Youth Ministry, and the various other ministries supported by the people of St. Bede. School columns include: Grades K - 8; the Pre-School; and the 'Before and After School' Program (EDP).

<u>Financial Highlights:</u> This past fiscal year reports a continuing reduction in the Sunday and Holy Day collections. Due to assistance from the Archdiocese and earmarked parish collections (*not part of this Operational report), St. Bede reduced its total outstanding debt by \$80,520 in FY11, which includes a reduction in the Faith Formation Building Construction Loan by \$127,986! Using good fiscal sense, we continue to pay down our higher interest rate construction loan, which is partially offset by an additional lower rate operating loan.
